Chairman Pro Tem and Secretary Pro Tem:

2016 Board Appointments:

2016 Professional Appointments:

Solicitor

Engineer Sewer & Water

Karl Bolognese made a motion to appoint Systems Design Engineering, Inc. and Greg Unger as Engineer at the proposed rate for Maiden creek Township Authority, seconded by James Nothwehr. Hearing no questions, the motion passed unanimously.

Pension Plan Administrator

The Board agreed that the Authority Chairman will be Pension Plan Administrator.

Karl Bolognese made a motion to appoint Dan Novakovich as Pension Plan Administrator, seconded by James Nothwehr. Hearing no questions, the motion passed unanimously.

Auditor

Karl Bolognese made a motion to appoint Kosmerl & Company as auditor for the Authority, seconded by James Nothwehr. Hearing no questions, the motion passed unanimously.

Recording Secretary

Karl Bolognese made a motion to appoint Meagan Dompkowski as the Recording Secretary for Maiden Creek Township Authority, seconded by James Nothwehr. Hearing no questions, the motion passed unanimously.

Depositories for Authority Funds

Karl Bolognese made a motion to retain Vist Bank, Commonwealth Financial and Geneos Wealth Management as the depository for Authority funds, seconded by James Nothwehr. Hearing no questions, the motion passed unanimously.

2016 Committee Assignments:

Karl Bolognese made a motion to adopt the remaining appointments as they stand, seconded by James Nothwehr. Hearing no questions, the motion passed unanimously.

The following Board members were signed to committees: Personnel Committee – Karl Bolognese and Dan Novakovich with James Nothwehr as an alternate; Administrative Committee – Jack May and Jerry Hartman; Operations Committee – Jerry Hartman and James Nothwehr.

2016 Meeting Dates:

The Board ratified that the 2016 Maiden Creek Township Authority meetings would take place on the second Wednesday of each month at 10:00 a.m.

A motion was made by Karl Bolognese to authorize the advertisement of the 2016 meeting dates, seconded by James Nothwehr. Hearing no questions, the motion passed unanimously.

2016 Compensation:

Dan Novakovich made a motion to retain the Authority Board monthly compensation at the current rate, seconded by Jerry Hartman. Hearing no questions, the motion passed unanimously.
